#### **Introduction**

Charles Wilson Engineers Ltd is opposed to, and strongly prohibits, all forms of human trafficking and slavery and takes all reasonable steps to ensure the promotion of sound, moral and ethical business practices throughout the organisation.

#### **Our Business and Supply Chains**

Charles Wilson Engineers Ltd is an equipment rental business that operates sites across the United Kingdom. The Company does not operate outside of the UK but does sometimes supply overseas businesses working in the UK. Our hire fleet equipment suppliers are predominantly based within the European Union. Charles Wilson Engineers Ltd does not operate in high risk areas and considers none of its activities to be at high risk of slavery or human trafficking.

#### **Commitments**

Charles Wilson Engineers Ltd is committed to ensuring that there is no human trafficking or modern slavery within any part of our organisation. The Company is committed to acting ethically and with integrity and transparency in its business dealings and relationships with both customers and suppliers.

#### **Policies**

Charles Wilson Engineers Ltd will continue to purchase hire fleet rental equipment from reputable suppliers whose products carry the appropriate CE mark.


Charles Wilson Engineers Ltd expects our valued suppliers to undertake all reasonable and practical steps to ensure that appropriate standards are being implemented.
